Councillor James advised the Council the ongoing issues regarding the playing fields were still being discussed at Bridgend County Borough Council and there were proposals to arrange a meeting with both parties and their respective Councillors to discuss the matter further.

#### 42.15 Correspondence

All matters of correspondence were duly noted. The War Memorial plaque cenotaph was discussed and it was agreed a cenotaph would be preferable to a plaque and it could possibly be placed in the grounds of the Village Hall. The Clerk to obtain prices and research possibly grants.

#### 43.15 Planning

## 46.15 Rights of Way

Councillor James advised Footpath 38 was still a mess and would cost £250 to put right. Bridgend County Borough Council has requested the community council make a donation to repairing the same. This matter discussed and it was agreed to pay half the costs. The Clerk to liaise with Councillor James in this regard.

Councillor D Jones advised the grass at footpath 24 has been cut.

### 47.15 Crossing

The Clerk advised the Council that an applicant was successful in applying for the crossing patrol position outside Cwmfelin School. The post is subject to various checks etc but it is hopeful the applicant will be in place by the start of the new school year in September.

Talks have been held with regards the possibility of placing a crossing at Llan Village Square as the proposed crossing outside Cwmfelin School was rejected. It would appear Bridgend County Borough Council would approve the site however the Clerk to contact Tony Godsall in this regard to obtain cost estimates etc.

#### 48.15 Safety Railing

The Clerk advised she had spoken with Bridgend Council and the railings had been ordered and should be fitted shortly.

#### 49.15 Replacement Councillor

Councillor Les Jones advised he would not be returning to his position on the Council. The Clerk therefore to advertise the position and should there be no candidates after 28 days the position could be eligible for co option.

#### 50.15 Litter Bins

Councillor James advised he was meeting with John Clarke of Bridgend Council with regards the litter bins on June 10<sup>th</sup> so hopefully progress can be made imminently.

Councillor Berry advised he had spoken with the contractors and the signs are in the process of being made.

## 52.15 Ysgol Gyfun Llangynwyd

Councillor James advised the school were turning the fields into vegetable plots and inmates of HMP Parc were also taking part. It was noted the community council provide Maesteg Comprehensive with an annual donation of £50 for a green award the be presented and Councillor James asked the Council if the same could be done for Ysgol Gyfun Llangynwyd and it was unanimously agreed.
