4. Police Matters:

 Crime figures from August 2022 to January 2023 were issued to Councillors prior to the meeting. The PCSOs explained that there was nothing to report which could have an impact on the wider community, and that if there was, the Community Council would be advised accordingly. They also explained that the figures under the crime description headings on the monthly reports can change through the investigative process, e.g., cases can be dropped, etc; there have been no burglaries since 2021.

• The PCSOs advised that the parking issues being experienced at both primary schools in the area are not uncommon, most schools in the Borough experience similar issues, and that this is policed by Bridgend County Borough Council (BCBC); parking attendants and 'Roly Patroly' visit periodically, and penalty charge notices are issued if and when appropriate. The Police will only get involved if a criminal offence has occurred, they cannot get involved in any procedural issues; what BCBC is doing or not doing. The provision of CCTV at schools is not something that the Local Authority is considering.
